1. Use INK or BALLPOINT pen, not pencil. Signers must fill in ALL blanks on their line. On Signature line, Sign name, do not print. Print address. Print name below signature.
2. Sign John R. Doe (not J.R. Doe).
3. Sign Mary Doe (not Mrs. J.R. Doe).
4. Signer writes in present residence.
5. Signing shall be done in the presence of the subscribing witness, a qualified voter, who shall complete and sign the statement at the bottom of the petition form.
6. A person signing the form as a petitioner may NOT sign the same form as a subscribing witness. A signing petitioner may, of course, act as witness on another form that he or she does not sign as a petitioner.
7. No person shall sign more than one petition as a petitioner.
8. NOTE: If you are obtaining signatures, then you become the subscribing witness and you MAY NOT sign as a petitioner on that form. The reason is that you may not be the witness for your own signature.
9. While it is desirable to have all spaces filled in, you should submit the signatures that you have obtained even if not all positions are completed.
